Southampton County Public Schools is participating in the Summer Food Service Program. Meals will be provided to all children without charge and are the same for all children regardless of race, color, national origin, sex (including gender identity and sexual orientation), disability or age, and there will be no discrimination in the course of the meal service. Meals will be provided Monday-Thursdays from June 24, 2024 - July 25, 2024 (closed on July 3 & 4th), on a first come, first serve basis, at the sites and times as follows:

Riverdale Elementary School	Breakfast: 9:30am to 10:00am—Lunch: 12:00pm to 12:30pm
Southampton Middle School	Breakfast: 8:30am to 9:00am—Lunch: 12:00pm to 1:00pm
Southampton High School	Breakfast: 8:30am to 9:00am—Lunch: 11:30am to 12:00pm
